We also require that you take your new puppy to your vet with in the first 24 hours of receiving. Common puppy parasites as well as coccidia, and giardia are not covered in this guarantee as we are on a very strict vaccination and deworming regimen until our puppies leave us.

Heifer Creek Kennel also guarantees this puppy to be free of genetic defects until the puppy reaches 1 year of age. If this puppy is found to have a genetic defect it will be replaced with another puppy of the same color & same sex from the first compatible available litter. (NO MONEY WILL BE REFUNDED.) Buyer is responsible for the shipping cost of the replacement puppy.

Because of the variety and quality of dog foods available (and all canine illnesses are NOT covered by vaccinations), we require that all Heifer Creek dogs be kept on "NuVet Plus Canine". This nutritional supplement is only available thru breeder recommendation. The order line number is 1-800-474-7044. Your order code is 461696. NuVet Labs send us a monthly report on which Heifer Creek dogs are being supplemented with NuVet Plus Canine. Note: This health guarantee will be considered null and void if you do not keep your pet on this supplement. We work hard to provide you with a healthy happy puppy it is your responsibility to keep them that way for a long healthy life.

If this puppy displays any indication of poor health within the first 24 hours. We must be contacted and the puppy must be brought back here and taken to our Veterinarian for any necessary treatment. Puppies that go out of state must be taken to a to a licensed veterinarian and signed documentation must come to us immediately. Failure to do so will cause this guarantee to become null and void.

Also this guarantee shall become null and void if the puppy is given vaccinations or medications other that what is specified on the medical record received with the puppy. Also all vaccines must be given in accordance to our schedule.
